STATUS REPORT

Clover Creek Solar Project LLC d/b/a New Frontiers Solar Park (the "Applicant" or "New Frontiers"), by and through counsel, hereby provides this Status Report pursuant to mitigation measure number 5 in the final order issued by the Kentucky State Board on Electric Generation and Transmission Siting ("Siting Board" or "Board") on May 2, 2025. Mitigation measure number 5 obligates New Frontiers to submit a status report to the Siting Board to update the Board on progress of the merchant electric generating facility and nonregulated electric transmission line (the "Project") every six months until the Project commences generating electricity.

To date, New Frontiers has not commenced construction of the Project. Breckinridge County has taken the position that Ordinance 2025-0121 (the "2025 Ordinance") applied to the Project. The Breckinridge County Circuit Court in Case No. 25-CI-00083 also concluded that the 2025 Ordinance applied to the Project and New Frontiers would be required to comply with the 2025 Ordinance if it wishes to commence construction of the Project.

New Frontiers has appealed the Circuit Court's decision to the Court of Appeals and was assigned Case No. 2025-CA-0983-MR. Certification of the record is anticipated within 30 days and briefs will be submitted thereafter.
