When Barry Lanham was a kid, he traveled with his grandfather, John Lanham, an old-time fiddle player, to festivals across Kentucky and Tennessee.

"Those who start young become the best dancers,'

Historians say clogging, which became the official state dance of Kentucky in 2006, is uniquely American.

They say it evolved from the foot-tapping folk dances of early Irish, Scottish, English and Dutch-German settlers in the eastern moun-

The word "clog," they say, is Gaelic for "time."

And clogging is a dance in time with the music, with the heel keeping rhythm.

The style, historians And he's taught thousands says, also owes a debt to Cherokee Indians, Black Americans and Russian Gypsies.

In 2006, Lanham took his Foot Stompin' Express Cloggers to China to perform during American Folk Dance and Music Week.

He said he has also taught clogging at Turks and Caicos Islands and has an invitation to go to England.
