Appalachian sold the land/homes at Zebulon Highway various times in 2009, 2011, 2013 and 2015. Therefore, Appalachian does not own any real property in the Zebulon Heights Community.

the Zebulon Heights Community. Additionally, Appalachian has never owned or operated the pump house currently owned and operated by Twin Diamond.

- 7. Due to the above response, Appalachian seeks to be dismissed as a party to this Investigation as they have no equitable or legal interest in this matter.
