## MOTION FOR EXTENSION OF TIME

Comes now Big Sandy Rural Electric Cooperative Corporation ("Big Sandy"), by counsel, and respectfully moves the Kentucky Public Service Commission ("Commission") to allow an extension of time for Big Sandy to file a Cost Allocation Manual ("CAM"). In support of this request, Big Sandy states as follows:

- 1. On October 1, 2024, Big Sandy filed an application for a general adjustment of rates. After discovery, intervenor testimony, rebuttal testimony, and a formal hearing the Commission issued an Order on June 20, 2025 approving certain rates and charges for Big Sandy.
- 2. Included in the June 20, 2025 Order is a finding that Big Sandy Forestry, LLC is an affiliate of Big Sandy. The Order also contained a requirement for Big Sandy to file proof of compliance with KRS 278.2213 and KRS 278.2207 within 60 days of the Order.
- 3. Big Sandy has been working diligently to comply with KRS 278.2213 and KRS 278.2207 by creating a CAM. Big Sandy has drafted the CAM; however, Big Sandy's Board of Directors will not have a chance to approve the CAM until August 28, 2025.
- 4. Big Sandy would like to wait and file its CAM showing proof of compliance with KRS 278.2213 and KRS 278.2207 until after the CAM has been approved by the Board of

Directors. Therefore, Big Sandy is requesting a 60-day extension, or until October 20, 2025 to file the CAM. If Big Sandy's Board of Directors approves of the CAM at the August 28, 2025, Board Meeting, Big Sandy will file the CAM much sooner than the 60-day requested extension. Big Sandy is requesting the additional time in the event the Board of Directors wants changes or updates to the CAM after it is presented on August 28, 2025.

WHEREFORE, on the basis of the foregoing, Big Sandy respectfully requests the Commission grant a 60-day extension for to file its CAM to show compliance KRS 278.2213 and KRS 278.2207
