**BIG SANDY RURAL ELECTRIC COOPERATIVE CORPORATION NOTICE OF
INTENT TO PLACE RATES INTO EFFECT PURSUANT TO KRS 278.190(2)**

Comes now Big Sandy Rural Electric Cooperative Corporation (“Big Sandy”), by counsel, and does hereby provide its notice pursuant to KRS 278.190(2) and the Commission’s October 18, 2024 Order suspending Big Sandy’s proposed rates until March 31, 2025. Big Sandy respectfully states as follows:

1. October 1, 2024, Big Sandy filed an application requesting an adjustment of rates. On October 18, 2024, the Commission entered an order that suspended the effective date of Big Sandy’s proposed rate increase and tariffs for five months, up to and including March 31, 2025.

2. Pursuant to KRS 278.190(2), this proceeding has not concluded nor an order made to date, therefore Big Sandy hereby gives notice that it will be putting proposed rates into effect for bills rendered on, or after, May 1, 2025, to align with Big Sandy’s billing cycle. Big Sandy will maintain its records in a manner as will enable it, its customers, or the Commission to determine the amounts to be refunded in the event a refund is awarded.

WHEREFORE, Big Sandy respectfully provides notice pursuant to KRS 278.190(2) that it will place rates into effect for bills rendered on, or after, May 1, 2025.
