He has worked in the power industry for the past three decades concentrating in the areas of integrated resource planning, strategic planning, market price forecasting, fuel procurement, risk assessment, and public policy. He holds a Bachelor of Science in Electrical Engineering from the University of Nebraska, a Master of Science in Electrical Engineering from Kansas State University, and a Master of Business Administration from Rockhurst University.

Tyler Marshall will be available to provide testimony on project permitting, environmental surveys, information in the cumulative environmental assessment, and decommissioning. Please note that Wes Turechek was previously identified as a sponsoring witness on decommissioning issues, but Mr. Turechek is unavailable for the hearing. Mr. Marshall will adopt filed reports and responses to information requests on decommissioning. In addition, given his expertise in environmental engineering, Mr. Marshall will also adopt filed reports and responses to information that Mr. Buresh was identified as a sponsoring witness. Mr. Marshall is a Principal Environmental Engineer with Stanley Consultants. He holds a Bachelor and Masters of Science in Civil Engineering from the Iowa State University.

Jeremy James will be available to provide testimony on air permitting and regulatory compliance. Mr. James is a Senior Environmental Scientist with Stanley Consultants. He holds a Bachelor of Arts (B.A.) focused in Environmental Science from Simpson College.

Dave Parzych will be available to provide testimony regarding the Project's noise analysis studies, including noise generation during construction and operation. Mr. Parzych is the President and Principal Consultant with Power Acoustics, Inc. He earned a Bachelor of Science in Engineering, Acoustics, from the University of Hartford in 1982.

Josh Coburn will be available to provide testimony regarding impact on traffic. He a Project Manager at Palmer Engineering and a graduate of the University of Kentucky, obtaining his Bachelor of Science in Civil Engineering in 2015. After graduating, Josh continued his transportation and traffic engineering development by obtaining his Professional Engineering license in 2021, his Professional Traffic Operations Engineer certification in 2021, and his Road Safety Professional certification in 2022. Throughout his career in traffic engineering, Josh has completed multiple traffic forecasts, traffic microsimulations, planning studies, and traffic impact studies. Josh has completed more than 80 traffic impact studies on a wide range of developments, such as large multi-land-use developments, solar farms, gas stations, fast food restaurants, car washes, large grocery stores, and residential developments.

His report was filed with the application and supplements thereto have been provided in response to data requests. Dr. Coomes has a Ph.D. in Economics, and is a Professor Emeritus of Economics at the University of Louisville, where he started teaching in 1985. Dr. Coomes has provided services to several renewable-energy projects submitted to the Siting Board.

Richard Kirkland will be available to provide testimony on the Kirkland Appraisals property-value report that was filed with the application, as well as responses to requests for information. Mr. Kirkland is a State Certified General Appraiser in Kentucky and North Carolina. He obtained his MAI designation in 2001 and holds a Bachelor of Arts from the University of North Carolina, Chapel Hill.
