Pursuant to the Commission’s January 16, 2025, Order in this matter,¹ Sierra Club hereby respectfully requests approval for its counsel, both in-state and out-of-state, to appear remotely at the January 29, 2025, informal conference, scheduled for 2:00 p.m. Eastern Standard Time.

Sierra Club’s counsel in the matter each have personal and professional commitments that would make it logistically difficult for them to travel to Frankfort, Kentucky to attend the hearing in person. Additionally, allowing counsel to appear remotely will conserve the considerable time and resources required for out-of-state counsel to travel to Kentucky.
