**THE GARRARD COUNTY WATER ASSOCIATION, INC.’S
RESPONSE TO DEFICIENCY**

Comes The Garrard County Water Association, Inc. (“Garrard County”), by and through counsel, pursuant to 807 KAR 5:068, and other relevant authority, and hereby responds to the deficiency letter entered on October 10, 2024 and states as follows:

1. On October 2, 2024, The Garrard County Water Association, Inc. filed its Application for an adjustment in rates pursuant to 807 KAR 5:068.
2. On October 10, 2024, the Commission entered a letter of deficiency in this record stating that the Application was deficient pursuant to 807 KAR 5:068 Section 1 (b): A schedule listing current and proposed rates, and that the “Current Rate of Bulk Sales” in the current tariff on file at the Commission did not match the listed “Bulk Sale Rates” in Exhibit C of the Application. Additionally, Exhibit C of the Application does not include Bulk Sales in the Proposed Rate increase or the Proposed Notice.
3. Upon reviewing the current tariff on file at the Commission, the mistake in the listed rate on Exhibit C of the Application was identified. An Amended Exhibit C is attached to this Response and Garrard County respectfully requests that the Amended Exhibit C be substituted to cure the identified deficiency.
4. Additionally, Garrard County is not requesting an increase in the Bulk Sale Rate

and therefore, did not list the rate in the Proposed Rate Increase or the Proposed Notice. Garrard County respectfully requests that this information cure this deficiency.

5. Upon review of the Application, Exhibit B, Calculations listed some of the rates incorrectly and those rates have been corrected in an Amended Exhibit B, attached to this Response and Garrard County respectfully requests that the Amended Exhibit B be substituted for the Exhibit B to the Application filed on October 2, 2024.

WHEREFORE, Garrard County respectfully requests that the attached Amended Exhibits B and C to its Application for adjustment in rates pursuant to 807 KAR 5:0068 replace the Exhibits B and C to the Application filed on October 2, 2024 to cure any deficiency.
