**JOINT MOTION FOR INFORMAL TECHNICAL CONFERENCE**

Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”) (jointly the “Companies”) respectfully move the Kentucky Public Service Commission (“Commission”) pursuant to 807 KAR 5:001, Section 9(4) and 807 KAR 5:058, Sections 2(3) and 11(2) to schedule an informal technical conference in the above-referenced proceeding to present an overview of the Companies’ Integrated Resource Plan (“IRP”) filing and answer any initial questions. In support of their Motion, the Companies state:

1. The Companies believe an informal technical conference will assist Commission Staff in the efficient review and evaluation of the Companies’ filing.
2. If an informal technical conference is held, the Companies will provide an overview of their IRP filing. Representatives of the Companies will be available to answer any initial questions of Commission Staff or intervening party regarding the filing.
3. The Companies expect to appear in-person at the Commission’s offices. However, the Companies are open to virtual participation by teleconference, if that is preferred by Commission Staff.

**WHEREFORE**, Kentucky Utilities Company and Louisville Gas and Electric Company respectfully request that the Commission schedule an informal technical conference in this matter.
