AN ORDINANCE AMENDING ORDINANCE NO. 2025-, THE CITY OF GLASGOW ANNUAL BUDGET FOR THE FISCAL YEAR 7-1-2024 THROUGH 6-30-2025 BY RECEIVING INTO THE GENERAL FUND \$271,907.49 FOR GLASGOW AIRPORT GRANT AND TRANSFERRING \$271,907.49 TO THE GLASGOW AIRPORT, AND RECEIVING INTO THE UNAPPROPRIATED GENERAL FUND \$2,000.00 FROM DONATIONS AND TRANSFERRING FROM THE UNAPPROPRIATED GENERAL FUND \$9,200 FOR BIT DEFENDER, TRANSFERRING \$1,000,000.00 FROM THE UNAPPROPRIATED GENERAL FUND TO THE UNAPPROPRIATED SANITATION LANDFILL FUND TO REPLACE MONIES FROM EARLIER TRANSFER, ALSO, TO TRANSFER FROM THE UNAPPROPRIATED SANITATION LANDFILL FUND \$87,900.00 FOR PARTS AND REPAIR OF EQUIPMENT.

BE IT HEREBY ORDAINED by the City of Glasgow, Kentucky, that the City of Glasgow Annual Budget for fiscal year 7-1-2024 through 6-30-2025, is hereby amended as follows: **SECTION ONE:** There is hereby received into the unappropriated General Fund the sum of \$271,907.49 into Admin. Miscellaneous Revenue Account 010-1110-6690 for Glasgow Airport Grants. **SECTION TWO:** There is hereby transferred from the unappropriated General Fund \$271,907.49 to the Miscellaneous Expense Account 010-1110-8499 for Glasgow Airport Reimbursement of Grant. **SECTION THREE:** There is hereby received into the unappropriated General Fund \$2,000.00 into the General Fund Police Department Account 010-2210-6090 Other Revenue for Donations. **SECTION FOUR:** There is hereby transferred from the unappropriated General Fund \$9,200.00 into the General Fund Police Department Technical Equipment Account 010-2210-8305 for Bit Defender. **SECTION FIVE:** There is hereby transferred from the unappropriated General Fund \$1,000,000.00 using Account 010-1110-6985 Admin Sanitation/Landfill Transfer to return funds from previous transfer. **SECTION SIX:** There is hereby transferred to the unappropriated Sanitation/Landfill Fund \$1,000,000.00 using Account 085-4430-6910 Landfill General Fund Transfer to move funds back from previous transfer. **SECTION SEVEN:** There is hereby transferred from the unappropriated Sanitation/Landfill Fund \$87,900.00 of which \$45,000.00 moved into the Landfill Maintenance and Repair Account 085-4430-8220 and \$42,900.00 moved into the Landfill Equipment Parts Account 085-4430-8315. **SECTION EIGHT:** This Ordinance shall take effect upon its passage and publication according to law.
