MOTION FOR LEAVE TO TENDER AND APPROVAL OF JOINT STIPULATION AND RECOMMENDATION

Comes Delta Natural Gas Company, Inc. ("Delta"), by counsel, and respectfully moves the Commission for leave to tender and approval of the Stipulation and Recommendation ("Stipulation") filed contemporaneously herewith, respectfully stating as follows:

- 1. On October 25, 2024, Delta filed a Notice of Intent to File an Application seeking adjustment of its natural gas rates and other approvals.
- 2. On November 25, 2024, Delta filed an Application seeking an adjustment of its natural gas rates and other approvals.
- 3. The Attorney General was permitted to intervene in this case by an Order entered on December 4, 2024. There are no other intervenors.
- 4. Following the completion of discovery, Delta and the Attorney General successfully negotiated an agreement by which all the issues presented in the Application are fully resolved. The agreement has been memorialized in writing as set forth in the Stipulation filed contemporaneously herewith. The Stipulation is also filed along with the supporting testimony of John B. Brown, the President of Delta. The Stipulation produces an outcome that is fair, just, and

reasonable; and for the reasons set forth therein and in Mr. Brown's supporting testimony, Delta moves for its approval as the full and final resolution of this matter.

WHEREFORE, Delta respectfully requests the Commission accept the Joint Stipulation and Recommendation and enter an order approving same.
