The Augusta City Council now being made aware that the parties engage in recent settlement negotiations at a recent settlement conference, and at such recent settlement conference, Mayor Laycock and Bracken County Water District Chairman Habermehl agreed upon the reasonableness of the wholesale water rate of \$2.75 per 1000 gallons, and on each seeking approval from their legislative body and board, respectively, and whereas

The Augusta City Council does hereby resolve that the Mayor is authorized to enter into a written Settlement Agreement with the Bracken County Water District setting the wholesale water rate at \$2.75 per 1000 gallons, and the Mayor is hereby further authorized to submit such executed Settlement Agreement to the Kentucky Public Service Commission for approval, provided that should no such executed Settlement Agreement be reached within a reasonable time, the Mayor is then hereby authorized to proceed to seek the wholesale water rate of \$2.967 per 1000 gallons, per recent Water Rate Study, in Kentucky Public Service Commission Case No. 2024-00349.
