**SHELBY ENERGY COOPERATIVE, INC. NOTICE OF INTENT TO PLACE RATES
INTO EFFECT PURSANT TO KRS 278.190(2)**

Comes now Shelby Energy Cooperative, Inc. (“Shelby Energy”), by counsel, and does hereby provide its notice pursuant to KRS 278.190(2) and the Commission’s January 6, 2025 Order suspending Shelby Energy’s proposed rates until June 9, 2025. Shelby Energy respectfully states as follows:

1. On December 5, 2024, Shelby Energy filed an application requesting an adjustment of rates. On January 6, 2025, the Commission entered an order that suspended the effective date of Shelby Energy’s proposed rate increase and tariffs for five months, up to and including June 9, 2025. On April 7, 2025, the Commission issued an Order approving of the request to waive a formal hearing and submit the matter for a decision on the record.

2. Pursuant to KRS 278.190(2), this proceeding has not concluded nor an order made to date, therefore, Shelby Energy hereby gives notice that it will be putting proposed rates into effect for bills rendered on, or after, July 1, 2025, to align with Shelby Energy’s billing cycle. Shelby Energy will maintain its records in a manner as will enable it, its customers, or the Commission to determine the amounts to be refunded in the event a refund is awarded.

WHEREFORE, Shelby Energy respectfully provides notice pursuant to KRS 278.190(2) that it will place rates into effect for bills rendered on, or after, July 1, 2025.
