Refer to the Application, Appendix C, page 5. Refer also to the Application, Appendix B, page 5 in Case No. 2024-00264.¹ Confirm that Duke Kentucky has correctly calculated the rates in this application with the budgetary changes that were proposed in Case No. 2024-00264. If not, then provide updated rates that reflect the budgetary changes.

RESPONSE:

Duke Energy Kentucky has correctly calculated the rates in this application with the budgetary changes that were proposed in Case No. 2024-00264.

Duke Energy Kentucky included the program changes and budgetary requirements in the July 2024 - June 2025 forecast as outlined on page 2 of Appendix C that were proposed in Case No. 2024-00264.

The data in Case No. 2024-00352 will not match the data in Case No. 2024-00264 because each represents a different fiscal year timeframe. Case No. 2024-00264 is an amendment filing to request changes to the already approved programs and budgets filed in Case No. 2023-00354. The Company files an amendment filing annually in August, as its opportunity to revise programs and/or budgets and to file any EM&V reports. This was ordered in Case No. 2012-00495 – *“In a year when DSM program evaluations, proposed*
