**DUKE ENERGY KENTUCKY, INC.'S NOTICE  
TO PLACE RATES INTO EFFECT**

---

Comes now Duke Energy Kentucky, Inc. (Duke Energy Kentucky or the Company), by and through counsel, and does hereby provide its notice pursuant to KRS 278.190(2) and the Commission's December 18, 2024 Order suspending Duke Energy Kentucky's proposed rates up to and including July 2, 2025. Duke Energy Kentucky respectfully states as follows:

1. On December 2, 2024, Duke Energy Kentucky filed an application for an adjustment of the electric rates.<sup>1</sup> On December 18, 2024, the Commission entered an order that suspended the effective dates of Duke Energy Kentucky's proposed rate increase and tariffs up to and including July 2, 2025.<sup>2</sup>

2. Pursuant to KRS 278.190(2), this proceeding has not concluded nor an order made to date, therefore Duke Energy Kentucky hereby gives notice that it will be putting

proposed rates into effect for service rendered on, or after, July 3, 2025.

3. Duke Energy Kentucky will maintain its records in a manner as will enable it, its customers, or the Commission to determine the amounts to be refunded in the event a refund is awarded.

WHEREFORE, on the basis of the foregoing, Duke Energy Kentucky respectfully provides notice pursuant to KRS 278.190(2) that it will place rates into effect for service rendered on, or after, July 3, 2025.
