## RESOLUTION OF THE ALLEN COUNTY WATER DISTRICT REGARDING PROPOSED INCREASE IN GLASGOW WHOLESALE WATER RATE AND AUTHORIZING CHAIRMAN TO FILE AN APPLICATION FOR A PURCHASE WATER ADJUSTMENT THE KENTUCKY PUBLIC SERVICE COMMISSION

WHEREAS, the Allen County Water District ("ACWD") is a water district created and organized under the provisions of KRS Chapter 74. As such, the ACWD is subject to the jurisdiction of the Kentucky Public Service Commission;

WHEREAS, KRS 278.180 and 807 KAR 5:068 provide a mechanism for the ACWD to propose adjustments to is water rates and charges;

WHEREAS, ACWD purchases water from Glasgow Water Company;

WHEREAS, Glasgow Water Company has proposed an increase in its wholesale water rate from \$1.95 per one thousand gallons to \$2.01 per one thousand gallons;

WHEREAS, the ACWD is allowed to adjust its rates to its customers through a Purchase Water Adjustment pursuant to 807 KAR 5:068;

NOW THEREFORE, it is hereby resolved by the ACWD Board of Commissioners as follows:

The facts, recitals and statements contained in the preamble of this Resolution are true and correct and are hereby affirmed and incorporated herein as a part of this Resolution.

The ACWD proposes to adjust its monthly water rates and charges as set forth in Appendix A, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The proposed rate adjustment shall not become effective until PSC approval has been obtained.

The chairman is hereby authorized and directed to prepare, execute and file with the PSC pursuant to 807 KAR 5:068, an application for a Purchase Water Adjustment, Tariff Sheets and any other documents that may be required by the PAC.

The Chairman, General Manager, Office Manager, and all others to whom the Chairman may delegate certain responsibilities are hereby further authorized and directed to take any and all other actions and to execute and deliver any and all other documents as may be reasonably necessary to implement this Resolution.

This Resolution shall take effect upon its adoption.
