**MOTION TO CLOSE CASE AND REMOVE**  
**FROM SITING BOARD’S DOCKET**

Comes now Owensboro Solar, LLC (“Owensboro Solar”), by counsel, and respectfully requests the Kentucky State Board Electric Generation and Transmission Siting (“Siting Board”) close this matter. Owensboro Solar respectfully states as follows:

1. On December 13, 2024, Owensboro Solar filed its Notice of Intent to file an application for a Certificate to Construct an approximately 150 megawatt (“MW”) merchant solar electric generating facility.
2. Pursuant to 807 KAR 5:110, Section 2(1), an application can be filed at least thirty (30) days but no more than six (6) months after the Notice of Intent has been filed.
3. At this time, Owensboro Solar no long intends to file an application for a Certificate to Construct a merchant solar electric generating facility and is requesting the Siting Board allow

this matter to be closed and removed from the Siting Board's docket. If in the future, Owensboro Solar believes it will file an application it will request a new docket to file an application.

WHEREFORE, based on the foregoing, Owensboro Solar respectfully requests the Siting Board permit this matter to be closed and removed from the Siting Board's docket.
