## SOUTH KENTUCKY RURAL ELECTRIC COOPERATIVE CORPORATION NOTICE OF INTENT TO PLACE RATES INTO EFFECT PURSANT TO KRS 278.190(2)

Comes now South Kentucky Rural Electric Cooperative Corporation ("South Kentucky"), by counsel, and does hereby provide its notice pursuant to KRS 278.190(2) and the Commission's February 19, 2025 Order suspending South Kentucky's proposed rates until August 5, 2025. South Kentucky respectfully states as follows:

- 1. On February 3, 2025, South Kentucky filed an application requesting an adjustment of rates. On February 19, 2025, the Commission entered an order that suspended the effective date of South Kentucky's proposed rate increase and tariffs for five months, up to and including August 5, 2025. On April 23, 2025, the Commission entered an order setting a Formal Hearing in this matter on July 17, 2025.
- 2. Pursuant to KRS 278.190(2), this proceeding has not concluded nor an order made to date, therefore, South Kentucky hereby gives notice that it will be putting proposed rates into effect for bills rendered on, or after, September 1, 2025, to align with South Kentucky's billing

cycle. South Kentucky will maintain its records in a manner as will enable it, its customers, or the Commission to determine the amounts to be refunded in the event a refund is awarded.

WHEREFORE, South Kentucky respectfully provides notice pursuant to KRS 278.190(2) that it will place rates into effect for bills rendered on, or after, September 1, 2025.
