Refer to ES Form 2.5 and ES Form 2.4 for the expense month of February

2021. The total expenses shown on ES Form 2.5 correctly sum to \$4,966,454 as shown, but the

amount carried forward to ES Form 2.4 is listed as \$4,396,580. Explain the discrepancy, and,

where appropriate, correct the 12-Month Totals and all affected calculations for the expense

months December 2021 and January 2022 under review.

Response 2. EKPC agrees that \$4,396,580 was a typographical error. The correct value

for February 2021 is \$4,966,454. EKPC has corrected Forms 1.1 and 2.4 for all months from

February 2021 through January 2022, see attachment PSC3.2a.pdf for the updated monthly

Form 2.4. Soley adjusting Form 2.4 for all impacted months is a reasonable method to calculate

the impact.

The difference between the billed amount of \$4,396,580 and the corrected amount of

\$4,966,454 is \$569,874 under-collection. The Owner-Member allocation on ES Form 1.1, Line 9

allocates the expenses recovered by Owner-Members, which reduces the recoverable amount to

\$561,263. The member system allocation on ES Form 1.1 leads to the small reduction of

\$8,611. The table below illustrates the true monthly under-recovery which can also be seen in attachment *PSC3.2b.pdf*.
