**APPLICATION TO CONSTRUCT  
A NON-REGULATED TRANSMISSION LINE**

Pursuant to KRS 278.714 and 807 KAR 5:110, Lost City Renewables LLC (“Lost City”), by counsel, submits this application for a construction certificate to construct a non-regulated transmission line. In support of this application, Lost City states as follows:

1. Lost City is a limited liability company organized under the laws of Delaware on June 21, 2022, with a principal place of business of 12 W 15th Street, 15th Floor, New York, NY 10011. Lost City’s phone number is (843) 510-5254. Lost City is authorized to do business in Kentucky as of December 5, 2024.

2. The proposed Lost City nonregulated electric transmission line is proposed to be constructed in Muhlenberg and Logan counties to support the Lost City’s 250 MW solar facility, which is the subject of Case No. 2024-00406. The 161kV transmission line would connect the proposed generation substation to TVA’s existing 161kV transmission system via future tap and installation of a TVA owned switching station which will be located at the TVA Lost City

Substation located at 2557 Lost City Road, Lewisburg, KY 42256. The transmission line will be up to approximately 10.5 miles in length.

3. Pursuant to 278.714, and 807 KAR 5:100, Lost City will submit its application fee for this filing.

4. Lost City, through its attorneys identified below, has the ability to receive electronic transmissions in this matter at the electronic mail addresses listed below.

5. Information required to be filed by statutes and regulation is attached hereto. Please refer to the attached Table of Contents and related information.

WHEREFORE, Lost City respectfully requests that the Siting Board (a) accept for filing this Application in accordance with 807 KAR 5:110, Section 3(3) and (b) approve a construction certificate for a transmission line.
