**SOUTHERN RENEWABLE ENERGY ASSOCIATION’S
MOTION TO ALLOW REMOTE PARTICIPATION
AT THE INFORMAL CONFERENCE**

Comes now the Southern Renewable Energy Association (“SREA”), by and through counsel, and, moves the Public Service Commission (“PSC” or “Commission”) for an Order allowing remote participation by a representative of SREA at the Informal Conference in the instant case. In support of the Motion, SREA states the following.

On July 16, 2025, the Commission entered an Order granting the Joint Motion of the Kentucky Utilities Company (“KU”) and Louisville Gas and Electric Company (“LG&E”) for an Informal Conference is scheduled to start on July 22, 2025. SREA will participate in the Conference through Counsel who will appear in person; therefore, SREA will have a representative at the Commission’s offices during the Conference.

Whit Cox, Regulatory Director of SREA, is part of the SREA team working on this case, and his office is located out-of-state. Travel to Frankfort, Kentucky, for Mr. Cox would entail either an eight-hour drive or, alternatively, a multi-leg flight. Travel to the Conference, therefore, poses an undue hardship upon Mr. Cox.

The Conference was requested for the purpose of discussing issues in the case and the possibility of resolving some or all of those issues by stipulation and recommendation. Mr. Cox, as a representative of SREA with authority to negotiate, is essential to SREA's participation in the Conference. Mr. Cox's ability to participate in the Conference furthers the purposes of the Conference, and his remote participation would not be unduly disruptive.

WHEREFORE, SREA moves for an Order allowing remote participation in the Conference by Mr. Cox.
