JOINT MOTION OF KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC COMPANY FOR LEAVE TO FILE JOINT STIPULATION TESTIMONY OF LONNIE E. BELLAR AND ROBERT M. CONROY

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (collectively "Companies") hereby respectfully move for leave to file the written Joint Stipulation Testimony of Lonnie E. Bellar and Robert M. Conroy, including Stipulation Testimony Exhibit 1, "Stipulation and Recommendation" ("Stipulation"). The parties to the Stipulation are the Companies; the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention ("AG"); Kentucky Industrial Utility Customers, Inc. ("KIUC"); Southern Renewable Energy Association ("SREA"); and Kentucky Coal Association, Inc. ("KCA") (collectively, the "Stipulating Parties").

As grounds for their motion, the Companies state that representatives of all parties to this proceeding participated in a settlement conference July 22 and 23, 2025, to discuss the possible compromise and settlement of the issues associated with the Companies' applications in this proceeding, including the application filed by KU in the case consolidated into this case, Case No.

2025-00105.¹ As a result of this conference, the Stipulating Parties entered into a complete settlement of all issues in these proceeding.

WHEREFORE, KU and LG&E request the Commission enter an order granting the Companies leave to file the Joint Stipulation Testimony of Lonnie E. Bellar and Robert M. Conroy, and the exhibit thereto, namely the Stipulation, in the record of this proceeding.
