MOTION TO EXCUSE WITNESSES OF THE ATTORNEY GENERAL AND KIUC

Comes now the Attorney General of the Commonwealth of Kentucky, by his Office of Rate Intervention (“Attorney General”) and Kentucky Industrial Utility Customers (“KIUC”), and request that their Expert Witnesses, Lane Kollen and Leah Wellborn, be excused from appearing at the hearing scheduled in this matter.

Pursuant to the Scheduling Order of March 13, 2025, witnesses who sponsor testimony shall appear in person at hearing. Lane Kollen and Leah Wellborn provided testimony as Expert Witnesses on behalf of the Attorney General and KIUC. This was filed in the record on June 16, 2025. On July 29, 2025, the LG&E and KU filed a Stipulation and Recommendation in the record, which was signed by and fully supported by the Attorney General and KIUC, among others.

The Attorney General and KIUC request that Lane Kollen and Leah Wellborn be excused from appearing at and participating in the Hearing scheduled to begin on August 4, 2025.

LG&E and KU have confirmed, by counsel, that they do not oppose this Motion.
