JOINT PETITION OF LOUISVILLE GAS AND ELECTRIC COMPANY AND KENTUCKY UTILITIES COMPANY FOR CONFIDENTIAL PROTECTION

Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") (collectively, "Companies") petition the Kentucky Public Service Commission ("Commission") pursuant to 807 KAR 5:001, Section 13 and KRS 61.878 to grant confidential protection for certain information the Companies are providing as part of their supplemental response to Attorney General and Kentucky Industrial Utility Customers, Inc. ("AG-KIUC") request for information No. AG-KIUC 3-3(b).

Confidential Commercial Information – KRS 61.878(1)(c)(1)

1. Under the Kentucky Open Records Act, the Commission is entitled to withhold from public disclosure commercially sensitive information to the extent that open disclosure would permit an unfair commercial advantage to competitors of the entity disclosing the information to the Commission. Public disclosure of the information identified herein would, in fact, prompt such a result for the reasons set forth below.

Engineering Procurement and Construction Contract with Third Party

- 2. The Companies' response to AG-KIUC 3-3(b) includes their fully executed Engineering, Procurement, and Construction ("EPC") contract with a third party who has not yet initiated service, which is subject to a non-disclosure agreement. This contract includes cost estimates and specific performance terms that have not been public disclosed and are the result of negotiations between the Companies and the new customer. Public disclosure of this information would give the Companies' contractors and vendors access to the Companies' contracting practices and insight into the Companies' estimates of the costs and scope of the site-readiness work required to serve this new customer. Public disclosure is therefore likely to impact the Companies' ability to negotiate fairly with prospective contractors and vendors, which would increase capital costs and harm the Companies' competitive position in the wholesale power market. Further, public disclosure would give the Companies' competitors insights into the Companies' negotiation process and gain an unfair commercial advantage in attracting the Companies' prospective customers to the Companies' competitors' service territories.
- 3. All such commercial harms would ultimately harm LG&E's and KU's customers, who may have to pay higher rates if the disclosed information increases the Companies' costs or impairs the Companies' efforts to attract new customers. The Commission has granted confidential protection to similar information in the past.²

4. For these reasons, the Companies request that the Commission grant confidential protection to the executed EPC contract being produced as part of the Companies' supplemental response to AG-KIUC 3-3(b).

Confidential Information Subject to this Petition

- 5. The information for which the Companies are seeking confidential treatment is not known outside of LG&E and KU, its contractors, and the countersigning parties; is not disseminated within LG&E and KU except to those employees with a legitimate business need to know and act upon the information; and is generally recognized as confidential and proprietary information in the energy industry.
- 6. The Commission has consistently granted confidential protection to similar information in previous cases.³
- 7. The Companies will disclose the confidential information, pursuant to a confidentiality agreement, to intervenors with legitimate interests in the information and as required by the Commission.
- 8. If the Commission disagrees with this request for confidential protection, it must hold an evidentiary hearing (a) to protect the Companies' due process rights and (b) to supply the Commission with a complete record to enable it to reach a decision about this matter.⁴
- 9. In compliance with 807 KAR 5:001, Section 13, LG&E and KU are providing written notification that the attachment to the Companies' supplemental response to AG-KIUC Item No. 3-3(b) is confidential in full.

10. The Companies will upload the confidential information to its encrypted file-share site for the Commission's retrieval. Access to the encrypted file-share site will be provided to intervenors pursuant to a confidentiality agreement.

WHEREFORE, Louisville Gas and Electric Company and Kentucky Utilities Company respectfully request that the Commission grant confidential protection for all the information described herein.
