MOTION FOR INFORMAL CONFERENCE

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by and through the undersigned counsel, pursuant to 807 KAR 5:001 Section 9 and other applicable law and does hereby submit its request to conduct an informal conference in this case. EKPC requests to hold this conference virtually on or before **March 25, 2025**. In support of this motion, EKPC respectfully states as follows:

1. On July 2, 2025, EKPC filed an application requesting the Commission approve EKPC’s proposed amendments to its Environmental Compliance Plan (“Compliance Plan”) and grant EKPC authority to recover the costs associated with the Compliance Plan through its existing environmental surcharge. The Commission issued an order on December 23, 2025, approving of all of the projects in the Compliance Plan and recovery except Project 44.¹

2. EKPC requested rehearing regarding Project 44.² The Commission granted rehearing and allowed for Commission Staff to issue requests for information.³ Commission Staff issued its First Rehearing Request for Information and EKPC responded on February 20, 2025.⁴

3. Commission Staff has issued its Second Rehearing Request for Information.⁵ EKPC believes an informal conference will provide assistance and clarity regarding Project 44.

For the foregoing reasons, EKPC respectfully requests that the Commission schedule an informal conference to discuss the issues present in Staff's Second Request for Rehearing.
