**Kentucky Power Company's Motion For Extension of Time**

Kentucky Power Company ("Kentucky Power" or "Company") respectfully moves the Public Service Commission of Kentucky ("Commission") pursuant its March 25, 2025 Order in this case for a short extension of time through April 3, 2025 to file responses to certain Commission Staff data requests issued on March 25, 2025.

Commission Staff issued its first set of data requests, consisting of 27 distinct requests, upon Kentucky Power on March 25, 2025. The Commission's March 25, 2025 procedural schedule requires Kentucky Power to files its responses to those data requests no later than March 31, 2025, or four business days later. Kentucky Power began working immediately to prepare responses to all 27 data requests within that time frame. Despite Kentucky Power's diligence and best efforts to prepare complete responses to each of the requests, Kentucky Power requires additional time to fully respond to eight of Commission Staff data requests: 1-7, 1-11, 1-14, 1-15, 1-21, 1-22, 1-24, and 1-27. Kentucky Power communicated with Commission Staff on March 28, 2025, that Kentucky Power may require and request additional time to respond to some of Staff's data requests. Kentucky Power therefore requests a short extension of three additional business days, through April 3, 2025, but will file the remaining responses as soon as is practicable before that time, if possible. Kentucky Power is timely filing all other responses to data requests and attachments thereto.

WHEREFORE, Kentucky Power Company respectfully requests that the Commission enter an Order:

1. Granting Kentucky Power a short extension of time through April 3, 2025 to file responses to Commission Staff data requests 1-7, 1-11, 1-14, 1-15, 1-21, 1-22, 1-24, and 1-27 as described herein; and
2. Granting such further relief to which the Company may be entitled.
