**Kentucky Power Company’s Request To Submit Matter For Decision On The Record**

In accordance with the Public Service Commission of Kentucky’s (“Commission”) April 3, 2025 Order, Kentucky Power Company (“Kentucky Power” or “Company”) respectfully requests that this matter be submitted for decision on the record and without a hearing. In support of its request, Kentucky Power states as follows:

The Commission issued its procedural schedule in this case by order dated March 25, 2025. That procedural schedule was amended by order dated April 3, 2025 (“Procedural Schedule”). The Procedural Schedule provides that supplemental data requests to Kentucky Power must be filed by April 8, 2025 and Kentucky Power’s responses to those data requests must be filed by April 15, 2025. The Procedural Schedule provides that Kentucky Power may request a hearing or to submit this matter for a decision on the record by April 17, 2025. No supplemental data requests were issued on April 8, 2025.

Given that no supplemental data requests were issued on April 8, 2025, the remaining deadlines in the Procedural Schedule are redundant. Kentucky Power therefore respectfully requests that this matter be submitted for decision on the record as of the date of this filing.

However, the Company will defer to the Commission if the Commission or Commission Staff determine that a hearing is needed or would be beneficial to supplement the record of this matter with additional evidence so that the Company’s application may be granted. In that event,

the Company would be amenable to making its witnesses available for any such hearing at the convenience of the Commission. The Company also is willing to attend an informal conference with Commission Staff and the parties to discuss any outstanding issues, any evidence submitted, or to discuss any other matters that would aid in the handling and disposition of the case.
