MINUTES OF CALLED MEETING OF BOARD OF DIRECTORS OF GRAVES COUNTY WATER DISTRICT HELD FEBRUARY 27, 2024

Pursuant to notice to each director, a meeting of the Board of Directors of the Graves County Water District was held at 8:00 a.m. on Tuesday, February 27, 2024, at the Mayfield Electric & Water Systems office, 301 East Broadway, Mayfield, Kentucky 42066. The following directors were present: Bill Sears, Mark Carrico, Jacob Chambers, Steve Mason, Mickey Grooms, Darren Stone, and Phillip Carr. Others present were Brent Shultz (Water/Wastewater Manager) and Glenn Denton with Denton Law Firm.

ITEM I: Chairman Sears called the meeting to order. He determined that a quorum was present.

ITEM II: Upon motion made by Mr. Grooms, seconded by Mr. Carr, and unanimously carried by all directors present, the following was adopted:

He also went over with the Board a communications issue and how it had caused fluctuations at the water tank. After additional discussion by the Board, upon motion made by Mr. Carrico, seconded by Mr. Carr, and unanimously carried by all directors present, the following was adopted:

ITEM V: Mr. Shultz then presented the mowing proposals for consideration. The Board discussed and considered four (4) bids. Topics included the following:

- One contractor had previously worked for the District and had done the work for the District for quite some time;
- One contractor may have an actual or perceived conflict of interest that could lead to operational difficulties;
- The Board's desire to determine the most responsive and qualified bidder.
- Additionally, Mr. Shultz noted that the District would be doing some clean up work in-house for two (2) different locations.

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF THE GRAVES COUNTY WATER DISTRICT PROPOSING ADJUSTMENTS TO ITS WATER RATES AND CHARGES AND AUTHORIZING ITS CHAIRMAN TO FILE AN APPLICATION WITH THE PSC SEEKING APPROVAL OF THE PROPOSED RATE ADJUSTMENT

WHEREAS, the Graves County Water District (District) is a water District created and organized under the provisions of KRS Chapter 273. The District is subject to the jurisdiction of the Kentucky Public Service Commission ("PSC");

WHEREAS, prudent financial management dictates that the District take appropriate action to adjust its water rates and charges; and

WHEREAS, KRS 278.180 and 807 KAR 5:076 provide the legal mechanism for the District to propose adjustments to its water rates and charges;

NOW, THEREFORE, IT IS HEREBY RESOLVED BY THE BOARD OF COMMISSIONERS OF GRAVES COUNTY WATER DISTIRCT AS FOLLOWS:

Section 1. The facts, recitals, and statements contained in the foregoing preamble of this Resolution are true and correct and are hereby affirmed and incorporated as a part of this Resolution.

Section 2. The District proposes to adjust its monthly water rates and charges as set forth in Appendix A, which is attached hereto and is incorporated herein by reference as a part of this Resolution. The proposed rates and charges set forth in Appendix A are subject to any minor adjustments that may be made by the PSC. The proposed rate adjustment shall not become effective until PSC approval has been obtained.

Section 3. The Chairman and Manager are hereby authorized and directed to prepare, execute, and file with the PSC, by utilizing the Alternative Rate Adjustment Procedure for Small Utilities set forth in 807 KAR 5:076, an Alternative Rate Filing ("ARF") Application, Tariff Sheets, and all other documents that may be required by the PSC.

Section 4. The Chairman, Manager, and all others to whom the President may delegate certain responsibilities are hereby further authorized and directed to take any and all other actions and to execute and deliver any and all other documents as may be reasonably necessary to implement this Resolution.

Section 5. This Resolution shall take effect upon its adoption.
