POST-HEARING BRIEF

Summer Shade Solar, LLC ("Summer Shade"), by counsel, and pursuant to 807 KAR 5:110, Section 7 and Kentucky State Board on Electric Generation and Transmission Siting ("Siting Board") order dated September 11, 2025, submits this Post-Hearing Brief. The record in this matter demonstrates that the Siting Board should approve a construction certificate for its application to construct a 106-megawatt merchant electric solar generating and battery energy storage facility with reasonable conditions as discussed throughout the record.

Questions were raised at the evidentiary hearing and in post-hearing data requests regarding setbacks proposed by the project. Summer Shade submits that its proposed setbacks are reasonable, particularly in this case, in which there is no one who has submitted oppositional comments in the record of this case. Summer Shade believes that support in the community and lack of opposition is reflective of its extended community outreach.

I. Community Outreach

Summer Shade Solar has made a substantial effort to engage the public in numerous ways regarding the Project, as demonstrated by the following discussion of community outreach in the Application:

Project representatives have been making regular outreach trips to the Project area throughout 2024 and 2025, including engagement with landowners adjacent to the Project as well as community officials. Additional methods of communication included phone calls, email, and informational flyers. Summer Shade Solar has made efforts to demonstrate their commitment to being a thoughtful corporate citizen in the community, and has made contributions to the Summer Shade Fish Fry, Founder's Day, and the Bowling Park food pantry. Project representatives have also joined the Chamber of Commerce and attended their quarterly breakfast events to stay engaged with community leaders and officials.

An in-person public meeting was held on January 29, 2025, at 5:30pm CDT in the Metcalfe County Government Building. This meeting was intended to inform the public about the Project and receive comments from the public. The notice for the in-person meeting was published on January 15, 2025, in *The Edmonton Herald News*, the local newspaper of general circulation in Metcalfe County, Kentucky. The tearsheet and affidavit of publication are attached as Attachment D. In addition, individual notices of the meeting were mailed to property owners adjoining the proposed project two weeks in advance of the meeting. Copies of these letters are also attached as Attachment D.

The Applicant conducted a public information meeting in the form of an open house. Project representatives and subject matter experts provided information in the development, permitting, construction, and operation of the proposed Summer Shade Solar Project. Attendees were able to view Project maps, ask questions, and take home Project materials. Please see Attachment D for copies of the materials provided at the public information meeting. In the public meeting, attendees were invited to examine various posterboard stations on topics including Applicant company information, a Project map and design overview, permitting process and timeline, environmental studies, Project equipment, local economic benefits, and visual renderings. The public information meeting was well attended by landowners, neighbors, public officials, and others. - Between 2024 and 2025, Summer Shade representatives attempted to meet with multiple adjoining neighbors, but their efforts were never answered. Flyers about the project that included contact information were left for these neighbors.¹

Summer Shade believes that this extensive outreach confirms its dedication to being a good community steward and further demonstrates that its proposed project design is acceptable to the community and nearby landowners.

II. Setbacks

The project's proposed setbacks are reasonable. Specifically, Summer Shade specially proposed the following condition:

Summer Shade Solar shall place panels, inverters, and substation equipment consistent with the distances to noise receptors to which it has committed in its maps and site plans. However, Summer Shade Solar shall not place solar panels or string inverters, if used, closer than 150 feet from a residence, church, or school, 25 feet from non-participating adjoining parcels, or 50 feet from adjacent roadways. Summer Shade Solar shall not place a central inverter, and if used, energy storage systems, closer than 350 feet from any adjacent residences, church, or school. These further setbacks shall not be required for residences owned by landowners involved in the Project that explicitly agree to lesser setbacks and have done so in writing.

To the extent that the Siting Board believes different setbacks should apply, KRS 278.708(6) states that "[t]he applicant shall be given the opportunity to present evidence to the board regarding any mitigation measures."

Questions arose about whether there are "residential neighborhoods," as defined by KRS 278.700, within 2,000 feet of the project site. As Summer Shade has explained, the project performed an initial cursory review of possible residential neighborhoods in the vicinity and determined that there were six areas that needed a more detailed evaluation to determine if they met the statutory definition of a residential neighborhood.² Information contained in Summer Shade's application relied on that initial cursory review. Upon a more in-depth review, Summer

Shade determined that none of the six areas were residential neighborhoods within 2,000 feet of the generating facilities as defined by KRS 278.700, based on its interpretation of the statutory definition of residential neighborhoods.

Following that determination and the filing of the Motion Regarding Setbacks, the Siting Board issued a decision in another case involving Lost City Renewables LLC that discussed the definition of residential neighborhood. In that case, the Siting Board determined that a residential neighborhood may not be defined based exclusively on parcel sizes but, rather, would be based on "any contiguous area so long as it is reasonable in shape."³ respectfully submits that defining residential neighborhoods based on parcel size presents a better approach, as it provides a brightline rule by which everyone can understand how to determine whether an area meets the statutory deadline. In contrast, every individual could have his or her own opinion on what is "reasonable in shape," thereby having multiple outcomes on whether areas are residential neighborhoods. This reasonable-in-shape interpretation of the statutory definition is seemingly unworkable, as it does not promote "the evenhanded, predictable, and consistent development of legal principles." Payne v. Tennessee, 501 U.S. 808, 827 (1991). "[T]he fact that a decision has proved 'unworkable' is a traditional ground for overruling it. Montejo v. Louisiana, 556 U.S. 778, 792 (2009); (citing Payne v. Tennessee, 501 U.S. 808, 827 (1991)).

In its Motion Regarding Setbacks, Summer Shade has explained why none of the identified six areas would meet the definition of a residential neighborhood based on certain factors, including size and number of the parcels and proximity to the project. Even if one were to consider a reasonably shaped area, it is not clear that there are any areas that have five or more

acres containing at least one residential structure per acre within 2,000 feet of generating facilities of the project.

For example, of the six identified areas, Area 6 has the closest residence to a solar panel—approximately 300 feet from residence to solar panel. There are five parcels in Area 6 with five residences. A rectangular area drawn around the five residences has an area of approximately 11.3 acres, as shown below. This would not meet the density requirements of at least one residential structure per acre.



It is not apparent to Summer Shade that any of the six identified areas (or any others) within 2,000 feet of planned generating facilities meet the definition of a residential neighborhood when considering a contiguous area that is reasonable in shape that has five or more acres containing at least one residential structure per acre.⁴ To the extent that the Siting Board, however, determines that there are any residential neighborhoods within 2,000 feet of the project, Summer Shade respectfully requests a deviation from the statutory setback requirements, pursuant to KRS 278.704(4). If such a determination is made, Summer Shade submits it is appropriate to base any approved distance based on the project plans as submitted in this case with a reasonable margin in case plans are slightly modified. The following table lists the proposed deviation, if appliable.⁵

The Siting Board has granted deviations to the statutory setback requirements to residential neighborhoods, allowing projects to construct generating facilities 300 feet or less from residential neighborhoods, including in these cases:

- Turkey Creek Solar, LLC, Case No. 2020-00040 (July 22, 2021) (300 feet)
- Mt. Olive Creek Solar, LLC, Case No. 2020-00226, (Nov. 3, 2021) (150 feet)
- Caldwell Solar, LLC, Case No. 2020-00244 (Apr. 8, 2022) (300 feet)
- Golden Solar, LLC, Case No. 2020-00243, (Feb. 21, 2023) (300 feet)
- Thoroughbred Solar, LLC, Case no. 2022-00115 (Apr. 10, 2023) (300 feet)
- Hummingbird Energy, LLC, Case No. 2022-00272 (Dec. 13, 2023) (300 feet)

Based on this precedent and the fact that there has been no public opposition filed in this case, Summer Shade believes that a 300-foot setback from a residence in a residential neighborhood (if any) is reasonable.

Accordingly, Summer Shade respectfully requests that the Siting Board (a) approve a construction certificate for Summer Shade to construct its Project, (b) confirm that no separate approval for a transmission line is necessary or, in the alternative, approve a construction certificate for a transmission line between the project switchyard and utility substation and (c) confirm that the setback requirements of KRS 278.704(2) do not apply to the Project because there are no residential neighborhoods, schools, hospitals, or nursing home facilities within 2,000 feet of the Project or, in the alternative, to grant a deviation from the setback requirements of KRS 278.704(2).
