LEGAL NOTICE REGARDING THE CUMBERLAND COUNTY WATER DISTRICT

Notice is hereby given that because of an increase in the cost of water purchased from the City of Burkesville, the Cumberland County Water District will increase its rates for services effective April 15, 2025. An application requesting the proposed rates was filed with the Kentucky Public Service Commission on March 19, 2025 to increase rates as follows:

As noted above, based on the increased cost of water from City of Burkesville, all rates will increase \$0.48 per 1,000 gallons. The monthly bill for a customer using an average of 4,205 gallons of water each month will increase from \$53.78 to \$55.80. This is an increase of \$2.02 or 3.76%.

The charges/rates contained in this notice are the charges/rates proposed by the Cumberland County Water District. However, the Public Service Commission may order charges/rates to be charged that differ from the proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rate detailed in this notice.
