MOTION TO SCHEDULE INFORMAL CONFERENCE

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by and through counsel, and respectfully requests the Kentucky Public Service Commission (“Commission”) to schedule an informal conference (“IC”) in this matter in order to discuss Commission Staff’s First Request for Information (“Staff’s First Request”) regarding EKPC’s need to engage a consultant to do the studies required to respond to certain of the responses. As grounds for this Motion EKPC states as follows:

On April 1, 2025 EKPC filed its 2025 Integrated Resource Plan (“2025 IRP”). On April 2, 2025 the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (“AG”) was granted intervention in this proceeding. On April 23, 2025 Staff’s First Request was issued.


Commission Staff’s First Request contained a hypothetical center load of 2.2 GW with questions regarding that hypothetical. In order for EKPC to respond to the questions involving this hypothetical studies would have to be completed. These are not studies that EKPC would do in house and would require the hiring of a consultant to complete. EKPC would like to have an IC with Commission Staff and the AG to discuss the issues related to the hypothetical posed in Staff’s First Request. EKPC would propose that the IC be set mid to late next week to avoid

prior commitments of EKPC personnel and counsel that would need to be present. EKPC does not oppose the IC being scheduled as a virtual meeting.

WHEREFORE, on the basis of the foregoing, EKPC respectfully requests that the Commission schedule and IC in these matters to discuss the Staff's First Request.


