APPLICATION

Kentucky Utilities Company ("KU"), pursuant to KRS 278.018(6), 807 KAR 5:001 Section 14, and 807 KAR 5:001, Section 22, hereby applies for approval of changes in its certified service territory as agreed to with Clark Energy Cooperative, Inc. ("Clark Energy").

- 1. Applicant KU's full name and business address are: Kentucky Utilities Company, One Quality Street, Lexington, Kentucky 40507. KU's mailing address is Kentucky Utilities Company c/o Louisville Gas and Electric Company, 2701 Eastpoint Parkway, Louisville, Kentucky 40223. KU may be reached by electronic mail at the electronic mail addresses of its counsel set forth below.
- 2. KU was incorporated in Kentucky on August 17, 1912, and in Virginia on November 26, 1991 (and effective as of December 1, 1991), and is in good standing in both Kentucky and Virginia.
- 3. KU is a public utility, as defined in KRS 278.010(3)(a), engaged in the electric business. KU generates and purchases electricity, and distributes and sells electricity at retail in the following counties in Central, Northern, Southeastern, and Western Kentucky:

5. Description of Changes in Service Territory:

As explained in this application and in the attached exhibits, KU and Clark Energy have individually agreed to the requested territorial change for two residential parcels of land described below. The proposed territorial boundary change serves the purposes of KRS 278.016. The

change avoids the wasteful duplication of facilities, the unnecessary encumbrance of the landscape, and prevents the waste of materials and natural resources. No existing customer will change electric provider.

KU was contacted by Loren Long, owner of Old Woodford Farm LLC at 2609 Athens-Boonesboro Road Ford, KY (parcel 017-028.06), requesting that KU cede its electric service territory to Clark Energy. Mr. Long intends to construct a home, barn/workshop, and a gate. This property spans the electric service territories of both KU and Clark Energy making this a "split territory" situation in which the utilities must confer in order to determine who is best suited to provide electric service. There are two additional split parcels nearby; parcel 017-028.05, which is adjacent to Mr. Long's entrance, and parcel 017-026.00, which is opposite Mr. Long's entrance.

KU engineering contacted Clark Energy engineering to discuss Mr. Long's property and together the staffs reviewed and studied the planned layout. Clark Energy has existing electric facilities in the immediate area. KU, on the other hand, would be required to extend its facilities to serve Mr. Long, at an approximate cost of \$20,000. Under these circumstances, KU agrees that it is in the customer's best interest to cede this territory to Clark Energy.

During discussions about Mr. Long's property, KU and Clark Energy determined that the two other parcels mentioned above are also located in split territories. KU currently provides electric service to both parcel 017-026.00 and parcel 017-028.05. KU and Clark Energy agree that the certified territory boundary line should now also be adjusted to fairly align with the current property lines and to reflect that fact that KU is currently serving those two parcels.

The proposed boundary line adjustments will allow each utility to prudently provide electrical service in order to reliably serve the three properties at issue in this application. The territorial maps and other attachments provided constitute the entire agreement between KU and

Clark Energy.

6. Agreement and Maps:

Application Exhibit 1 of this filing includes the summary list identifying KU and Clark

Energy personnel familiar with the specifics of the facilities available, the reason for the proposed

change (purposes served under KRS 278.016), and the agreement signed by both parties for the

properties involved. Application Exhibit 2 includes the signed territorial Ford 31-F-2 quadrant

map. Application Exhibit 3 includes the corresponding signed detailed site map.

WHEREFORE, KU hereby requests, pursuant to KRS 278.018, that the Commission

enter an order approving the updates to the Quadrant Map to reflect the current requested service

territory changes and the agreement between KU and Clark Energy.

AGREEMENT

Kentucky Utiliies Company (KU) and Clark Energy Cooperative (Clark Energy) hereby agree to redraw their territorial boundaries in order to match the property boundaries of three separate properties that are split territories. All properties are located in Clark County (Ford, KY).

The first change occurs at 2609 Athens-Boonesboro Road whereby KU will cede its territory to Clark Energy for service to a new home, gate and potential barn/workshop.

The two further changes are for properties adjacent to and across from 2609 Athens-Boonesboro Road – Parcel 017-028.05 and Parcel 017-026.00. KU currently provides electric service to these two parcels and will continue to do so. KU and Clark Energy agree that the certified territory boundary line should now be adjusted to align with the current property lines and to reflect that KU is currently serving these two parcels.

All changes avoid the wasteful duplication of facilities, the unnecessary encumbering of the landscape and prevents the waste of materials and natural resources.
