MOTION FOR DEVIATION

Comes now Farmers Rural Electric Cooperative Corporation ("Farmer"), by counsel, respectfully requests the Kentucky Public Service Commission ("Commission"), pursuant to 807 KAR 5:001, Section 22, and other applicable law to grant a deviation of certain portions of the notice requirement in 807 KAR 5:001, Section 9(2). Farmers is requesting a decision on this matter by **August 8, 2025**, because that is the date Kentucky Living must finalize the notice for printing. Respectfully, Farmers states as follows:

- On May 5, 2025, Farmers filed an application requesting an adjustment of rates.
 On July 23, 2025, the Commission entered an order setting a Formal Hearing in this matter on September 18, 2025.
- 2. 807 KAR 5:001, Section 9(2) requires a utility to provide notice of a hearing either by publication in a newspaper or by mailing notice to customers.¹ If the notice of the hearing is provided by newspaper publication, the notice must be published no less than seven (7) days and no more than twenty-one days (21).²

- 3. Farmers has the opportunity to publish notice of the September 18, 2025 Hearing in the September issue of *Kentucky Living* magazine. This will be mailed to members on, or about, September 1, 2025. Due to the length of time between the date the hearing was scheduled and the hearing date, Farmers also has the ability to coordinate with *Kentucky Living* for the July 2025 edition to be provided to all Farmers members, including those members that normally opt-out of receiving the magazine. A copy of the notice that will be provided to *Kentucky Living* is attached as Appendix A to this motion.
- 4. 807 KAR 5:001, Section 9(2)(a)(1) requires that a utility bear the cost of publication of the notice of a hearing. While rate case expense recovery is at the discretion of the Commission, it is typically for utilities to be allowed to recover the cost of publication of notice. In this case, Farmers has the opportunity to publish notice in *Kentucky Living*. Farmers expects significant cost savings for publication in *Kentucky Living* as opposed to the multiple newspapers that serve Farmers' service area.
- 6. Farmers will supplement the record at the time of publication with a copy of the notice and publisher's affidavit.

WHEREFORE, Farmers respectfully requests the Commission grant a deviation of 807 KAR 5:001, Section 9(2) pursuant to 807 KAR 5:001, Section 22 and permit Farmers to publish notice of the September 18, 2025 Formal Hearing by publication in *Kentucky Living*.
