Refer to the Direct Testimony of Greg Meyer (Meyer Direct Testimony), pages 17-18. Provide the calculation of the proposed 5 percent management/administrative team salaries assigned to Farmers Energy Propane Plus (FEPP). If no calculation can be provided, explain why 5 percent was chosen.

RESPONSE:

No additional calculations were used to determine the 5 percent adjustment. Mr. Meyer notes on page 17 of his Direct Testimony that the lack of allocation by Farmers Rural Electric Cooperative Corporation ("Farmers" or "the Company") was inappropriate. He chose 5 percent as a modest and conservative allocation in the absence of any support provided by the Company for the inclusion of the full salaries for management employees.
