Dear Ms. Bridwell:

The Green-Taylor Water District respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The District was previously notified by its supplier, City of Greensburg Water Department, that it would increase its wholesale rates by \$0.276 per 1000 gallons. This increase is effective on April 19, 2025. The result of this increase is \$63,645.32 in additional yearly supply cost for the District. This translates into \$0.20 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.

Mr. Riggle,

The City of Greensburg has long been a proud partner in providing clean, potable water to Green-Taylor Water District, and is committed to maintaining high standards. Likewise, we are committed to improving our infrastructure to the betterment of both our organizations, and ultimately the benefit of all our customers.

It is my judgement the City of Greensburg--having applied no wholesale rate adjustment since 2010--is best-served to meet those ends referenced above with the application of a modest rate adjustment.

The current wholesale rate charged to Green-Taylor is \$2.206 per 1,000 gallons, a figure which has stood firm for a decade and a half. The City of Greensburg is adopting a 12.5% wholesale rate adjustment, making the new rate \$2.482 per 1,000 gallons. This represents an annual increase of less than one percent per year.
