JOINT MOTION OF KENTUCKY UTILITIES COMPANY AND LOUISVILLE GAS AND ELECTRIC COMPANY FOR LEAVE TO FILE JOINT STIPULATION TESTIMONY OF ROBERT M. CONROY AND CHIRSTOPHER M. GARRETT

Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") (collectively, the "Companies") hereby respectfully move for leave to file the written Joint Stipulation Testimony of Robert M. Conroy and Christopher M. Garrett and the exhibits thereto, including Stipulation Testimony Exhibit 1, "Stipulation and Recommendation" ("Stipulation"). The parties to the Stipulation are the Companies; the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention; United States Department of Defense and All Other Federal Executive Agencies; Kentucky Industrial Utility Customers, Inc.; The Kroger Company; Lexington-Fayette Urban County Government; Louisville/Jefferson County Metro Government; Sierra Club; and Walmart, Inc. (collectively, the "Stipulating Parties.").

As grounds for their motion, the Companies state that representatives of all parties to these proceedings participated in a settlement conference October 8 and 9, 2025, and subsequent discussions over the next week, to discuss the possible compromise and settlement of the issues associated with the Companies' applications in these proceedings. As a result of this conference, the Stipulating Parties entered into a complete settlement of all issues in these proceedings.

WHEREFORE, Kentucky Utilities Company and Louisville Gas and Electric Company respectfully request the Commission enter an order granting the Companies leave to file the Joint Stipulation Testimony of Robert M. Conroy and Christopher M. Garrett, and the exhibits thereto, including the Stipulation, in the record of these proceedings.
