#### APPLICANTS' RESPONSE TO COMMISSION'S DATA REQUEST

APC Towers IV, LLC a Delaware limited liability company and Cellco Partnership d/b/a Verizon Wireless ("Joint Applicants"), by counsel, makes this Response to the Kentucky Public Service Commission Staff's First Request for Information to APC Towers IV LLC and Cellco Partnership d/b/a Verizon Wireless ("Data Request"). Applicant respectfully states, as follows:

**Question 1**: Provide a copy of all signed United States Postal Service Form 3811, otherwise known as "signed green cards," or a copy of the notice that the certified mail was returned to the Joint Applicants as undelivered by the United States Postal Service.
