Comes now, Bracken County Water District, ("BCWD"), by and through counsel, Mr. Jesse P. Melcher, Esq., and hereby files Notice of its request to withdrawal its request for a pass through rate adjustment and/or purchased water adjustment, with motion to dismiss the case, for the specified reasons stated herein.

The City of Augusta requested a wholesale rate increase of \$2.967 per 1000 gallons to go into effect on December 1, 2024, wherein, by Order of KY PSC, on November 19, 2024, the rate was suspended pursuant to KRS 278.190, for five months subject to 6 months. *See. KY PSC Case No. 2024-00349.* The City of Augusta filed a notice of intent to begin charging a wholesale rate increase of \$2.967, beginning May 1, 2025; however, the Kentucky Public Service Commission in the rate case, acknowledged a filing of a higher rate increase request by the City of Augusta and suspended any new rate increase until September 18, 2025. *See. Order of KY PSC, Case No. 2024-00349, dated April 18, 2025.*

Therefore, due to said sequence of events and that no new rate can begin until September 18, 2025; Bracken County Water District moves the Commission to dismiss this case, as Bracken County Water District will address any future approved wholesale water rate increase request by new case filing request.
