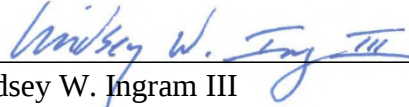
KENTUCKY-AMERICAN WATER COMPANY, INC.’S
MOTION FOR LEAVE TO FILE SUPPLEMENTAL DATA RESPONSE

Kentucky-American Water Company, Inc. (“KAWC”) hereby moves the Kentucky Public Service Commission (“Commission”) for leave to file the accompanying supplemental data response. After the September 23, 2025 hearing in this matter, Commission Staff issued data requests to KAWC and KAWC responded to them on October 6, 2023. Item 12 of those requests asked about the status of KAWC’s collective bargaining agreement (“CBA”) with its union employees. KAWC responded that the governing CBA would expire on October 31, 2025, but negotiations were planned with the goal of reaching a replacement CBA. As reflected in the accompanying supplemental response to Item 12, those negotiations did occur and were successful. The union ratified a new CBA on November 19, 2025 and a redlined version of it along with proof of its ratification are attached to the supplemental response. Pursuant to the Commission’s September 26, 2025 Order, this case was submitted for a decision at 12:01 a.m. on October 28, 2025. However, so that the Commission will have updated and current information about the status of the CBA that was the subject of its post-hearing discovery, KAWC seeks leave to file that information. Counsel for the Attorney General and Lexington-Fayette Urban County Government have authorized KAWC’s undersigned counsel to state that they do not plan on filing

a response to this motion. Therefore, KAWC respectfully requests leave to file the accompanying supplemental response to its October 6, 2025 response.

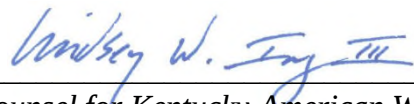
