**APPLICATION TO USE ABBREVIATED NOTICE PROCEDURES**

---

Applicant, Duke Energy Kentucky, Inc., (Duke Energy Kentucky or the Company), by counsel, pursuant to 807 KAR 5:001, Section 16(2)(b), 807 KAR 5:001, Section 17(5), and 807 KAR 5:001, Section 22, and other applicable law, hereby applies to the Kentucky Public Service Commission (Commission) for an order **no later than May 7, 2025** permitting Duke Energy Kentucky to provide abbreviated newspaper notice of its upcoming application for an adjustment to its natural gas base rates. Duke Energy Kentucky makes this application to reduce costs associated with its anticipated application for a natural gas base rate adjustment which will, in turn, reduce the level of any rate adjustment for the Company's' customers. Duke Energy Kentucky states in support of its application:

**I.     INTRODUCTION**

1.     Duke Energy Kentucky is a "utility" as defined in KRS 278.010(3) and is subject to the Commission's jurisdiction pursuant to KRS 278.040. In accordance with 807 KAR 5:001, Section 14(1), Duke Energy Kentucky is a Kentucky corporation with its principal office and principal place of business at 139 East Fourth Street Cincinnati, Ohio

45202.<sup>1</sup> The Company's local office in Kentucky is Duke Energy Erlanger Ops Center, 1262 Cox Road, Erlanger, Kentucky 41018. The Company further states that its electronic mail address for purposes of this matter is [KYfilings@duke-energy.com](mailto:KYfilings@duke-energy.com).

2. Duke Energy Kentucky is a utility engaged in the electric and natural gas business. As part of its electric service, Duke Energy Kentucky generates electricity, which it distributes and sells in Boone, Campbell, Grant, Kenton and Pendleton Counties. Duke Energy Kentucky purchases, sells, stores, and transports natural gas in Boone, Bracken, Campbell, Gallatin, Grant, Kenton and Pendleton Counties, Kentucky.

3. Duke Energy Kentucky anticipates filing an application for a general adjustment of its natural gas rates and charges and certain other relief on or about June 2, 2025.

## **II. METHOD OF NOTICE OF PUBLICATION**

4. 807 KAR 5:001, Section 17(2) requires a utility to provide notice to its customers of any general rate adjustment at the time of filing its application and further sets forth the permissible form and manner of such notice. The most practical and cost-effective means among the four methods of notice established by the regulation<sup>2</sup> is for Duke Energy Kentucky to provide the required notice publishing the notice once a week for three

3. Publishing notice once a week for three (3) consecutive weeks in a prominent manner in a newspaper of general circulation in the utility's service area, the first publication to be made no later than the date the application is submitted to the commission; or
4. Publishing notice in a trade publication or newsletter delivered to all customers no later than the date the application is submitted to the commission.

consecutive weeks in a prominent manner in each newspaper of general circulation in its service territory.

5. The scope and detail required by 807 KAR 5:001, Section 17 results in a lengthy newspaper notice. Duke Energy Kentucky's notice in connection with its 2021 application for general adjustment of its natural gas rates<sup>3</sup> comprised of 9 single-spaced typewritten 8 ½ x 11 pages. The Company estimates that, absent the relief requested by this Application, the notice to be published in connection with the Company's anticipated rate application would be of equal or greater length.

6. The notice is required to be published in each of the 5 newspapers of general circulation in the Company's service territory.

7. The cost of publishing the notice in conformity with the regulation is significant.<sup>4</sup> Based on the average cost of publication for the Company's natural gas rate cases in years past, and assuming normal inflationary cost increases, the Company estimates the cost of publishing the complete notice required by the Commission's regulations for the Company's anticipated rate case would total at least \$50,000. Whereas the cost of publishing the proposed abbreviated notice for three consecutive weeks, using recent, similarly sized publications, could total approximately \$10,000, for a total estimated savings of approximately \$40,000. The cost of publishing the notice constitutes a rate case expense that may be recovered through the newly established rates.

8. The abbreviated form of notice proposed below will reasonably inform the public of the Company's application while yielding significant savings as compared to the

full notice required by 807 KAR 5:001, Section 17.

### **III. DUKE ENERGY KENTUCKY'S PROPOSED FORM OF NOTICE**

9. Duke Energy Kentucky proposes to publish an abbreviated form of notice which will contain:

- a) the complete notice required by the Commission's regulation for the Company's proposed residential natural gas rate changes, as well as the additional information required for residential customers by the Commission's regulations;<sup>5</sup>
- b) an abbreviated notice of the adjustments to non-residential rates identifying each non-residential rate schedule the Company proposes to adjust and indicating the availability of further information concerning the proposed adjustments at the Duke Energy websites, as well as the Company's local office;<sup>6</sup> and
- c) notice that a complete printed or electronic copy of any applicable rate schedule may be obtained by written or electronic mail request to the Company.

A copy of the proposed abbreviated notice for Duke Energy Kentucky is attached hereto as Exhibit 2 to this Application.

10. Duke Energy Kentucky proposes to provide, in connection with the publication of its proposed abbreviated notice, the following additional public awareness measures:

- a) Duke Energy Kentucky will post at its local office a copy of the notice conforming to 807 KAR 5:001, Section 17. The conforming notice will be posted coincident with the first newspaper publication of its abbreviated notice and remain posted until completion of the Company's rate case.
- b) Duke Energy Kentucky will post on its website a copy of the notice conforming to 807 KAR 5:001, Section 17. The Company's website also will provide a hyperlink to the location on the Public

If the Commission nevertheless believes a coupon should be included, it will amend its proposed notice to do so.

Service Commission's website where case documents and tariff filings are available. The posting and hyperlink will be posted to the Company's website coincident with the first newspaper publication of its abbreviated notice and remain posted until completion of the Company's rate case.

c) A complete public version of the Company's application to adjust its rates and filed with the Commission will be posted on Duke Energy Kentucky's website. The application will be posted coincident with the filing of the Company's application to adjust its rates.

d) Duke Energy Kentucky will electronically upload, with its application to adjust its rates, a separate copy of its notice conforming to 807 KAR 5:001, Section 17. The copy will be entitled "Customer Notice of Rate Adjustment." The uploading of the separate copy is intended to enable customers reviewing the Commission's website to locate the notice without difficulty.

11. Duke Energy Kentucky anticipates the proposed abbreviated notice will reduce publication costs by approximately \$38,000.

12. Duke Energy Kentucky anticipates that the newspaper publication of the proposed abbreviated notice, in conjunction with the additional public awareness measures to be provided by Duke Energy Kentucky, will provide notice equal to the newspaper notice required by 807 KAR 5:001, Section 17.

13. 807 KAR 5:001, Section 22 authorizes the Public Service Commission to grant deviations from the requirements of Chapter 1 of Title 807 of the Kentucky Administrative Regulations upon the showing of good cause. In addition, 807 KAR 5:001, Section 16(2)(b) and Section 17(5) provide the Commission may authorize Duke Energy Kentucky to provide abbreviated newspaper notice. As set out above, good cause exists for the Commission to authorize Duke Energy Kentucky to publish the abbreviated notice described above, in conjunction with the other public awareness measures to be provided by Duke Energy Kentucky, in lieu of the full notice required by 807 KAR 5:001, Section 17.

WHEREFORE, Duke Energy Kentucky respectfully requests the Commission enter

an order no later than May 7, 2025:

1. Authorizing Duke Energy Kentucky to deviate from the requirements 807 KAR 5:001, Section 17 and authorizing the Company to publish, in conjunction with the other public awareness measures described above, the abbreviated notice of its proposed rate adjustment in the form set forth in Exhibit 2 to this application;

2. Granting Duke Energy Kentucky all other appropriate relief.
