## **MOTION TO SUBMIT**

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by and through counsel, pursuant to the May 23, 2025 Order of the Kentucky Public Service Commission ("Commission") and other applicable law, and for its Motion to Submit this case for an adjudication based upon the existing administrative record and without a formal evidentiary hearing, respectfully states as follows:

The Commission initiated this matter and established a procedural schedule by virtue of its order dated May 23, 2025. The Attorney General's Office ("AG") and Nucor Steel Gallatin ("Nucor") were granted intervention on June 2, 2025 and June 4, 2025. EKPC filed Direct Testimony on June 16, 2025. Commission Staff issued its Initial Requests for Information ("Staff's First Request") on June 27, 2025 and the AG issued its Initial Request for Information ("AG's First Request") on June 30, 2025. EKPC filed its responses to Staff's First Request and the AG's Frist Request on July 14, 2025. Commission Staff issued its Second Requests for Information ("Staff's Second Request") on July 25,2025. EKPC filed its responses to Commission Staff's Second Requests for Information on August 11, 2025. Commission Staff issued its Third Request

for Information ("Staff's Third Request") on August 20, 2025 and EKPC filed responses to Staff's Third Request on September 2, 2025. The AG did not issue any further requests for information to EKPC and Nucor did not issue any requests for information to EKPC. Neither the AG or Nucor filed testimony into the record of this proceeding. The remaining items on the procedural schedule are for responses to data requests by the intervenors and rebuttal testimony of EKPC. There have been no data requests issued to the intervenors in this proceeding so there will be no responses to file and no rebuttal testimony.

The May 23, 2025 Order allows the parties to request or waive a hearing on or before September 30, 2025. EKPC believes that the issues are straightforward and have been adequately addressed through the written discovery. The interests of administrative economy favor avoiding a formal hearing when it would be unlikely to result in the development of any additional facts. EKPC is unaware of any contested issues for which clarification might be necessary or advisable. Accordingly, EKPC does not believe that a formal evidentiary hearing is necessary and moves to submit the case for an adjudication based upon the existing administrative record without a formal evidentiary hearing.

WHEREFORE, on the basis of the foregoing, EKPC respectfully moves to submit this case for an adjudication based upon the existing administrative record and without a formal evidentiary hearing.
