

LEGAL NOTICE REGARDING THE WESTERN ROCKCASTLE WATER ASSOCIATION

Notice is hereby given that because of an increase in the cost of water purchased from the City of Mt. Vernon, the Western Rockcastle Water Association will increase its rates for services effective December 13, 2024. An application requesting the proposed rates was filed with the Kentucky Public Service Commission on April 25, 2025, to increase rates as follows:

As noted above, based on the increased cost of water from the City of Mt. Vernon all rates will increase \$0.56 per 1,000 gallons. The monthly bill for a customer using an average of 5,000 gallons of water each month will increase from \$53.75 to \$56.55. This is an increase of \$2.80 or 5.21%.

The charges/rates contained in this notice are the charges/rates proposed by the Western Rockcastle Water Association. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.
