Dear Ms. Bridwell:

The Green-Taylor Water District respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The District was previously notified by its supplier, City of Greensburg Water Department, that it would increase its wholesale rates by \$0.274 per 1000 gallons. This increase is effective on July 1, 2025. The result of this increase is \$63,150.15 in additional yearly supply cost for the District. This translates into \$0.20 per 1000 gallons of water sold to our customers. Therefore, we propose to increase our rates by that amount.



Mr. Riggle,

The City of Greensburg has long been a proud partner in providing clean, potable water to Green-Taylor Water District, and is committed to maintaining high standards. Likewise, we are committed to improving our infrastructure to the betterment of both our organizations, and ultimately the benefit of all our customers.

It is my judgement the City of Greensburg--having applied no wholesale rate adjustment since 2010--is best-served to meet those ends referenced above with the application of a modest rate adjustment.

The current wholesale rate charged to Green-Taylor is \$2.206 per 1,000 gallons, a figure which has stood firm for a decade and a half. The City of Greensburg is adopting a 12.5% wholesale rate adjustment, making the new rate \$2.482 per 1,000 gallons. This represents an annual increase of less than one percent per year.

NOTICE

On March 20, 2025, the City of Greensburg Water Department (Greensburg) filed with the Public Service Commission to increase its wholesale water rate to Green-Taylor Water District effective April 19, 2025. Due to the water purchase contract between Greensburg and Green-Taylor, Greensburg needs to revise the effective date to July 1, 2025. The proposed rate increase will still be as originally proposed, as set forth below.

As noted above, based on the increased cost of water from the City Greensburg Water Department, all rates will increase \$0.20 per 1,000 gallons. The monthly bill for a customer using an average of 4,765 gallons of water each month will increase from \$51.86 to \$52.82. This is an increase of \$0.96 or 1.85%.

The charges/rates contained in this notice are the charges/rates proposed by the Green-Taylor Water District. However, the Public Service Commission may order charges/rates to be charged that differ from these proposed charges/rates. Such action may result in charges/rates for consumers other than the charges/rates detailed in this notice.

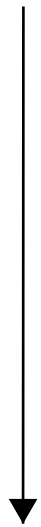
