CUSTOMER NOTICE TO PENDLETON COUNTY WATER DISTRICT

City of Falmouth is providing notice that it plans to file with the Public Service Commission, on or before April 23, 2025, to increase its wholesale water rate to Pendleton County Water District effective for water service on and after May 23, 2025. The proposed rate is as follows:

Pendleton County Water District purchased 71,283,560 gallons of water from City of Falmouth during 2024. Its average monthly purchases were 5,940,297 gallons. Under the current rate, Pendleton County Water District's average monthly bill is \$11,761.79. Under the proposed rate, Pendleton County Water District's average monthly bill will be \$15,741.79. This is an increase of \$3,980.00 per month or 33.84%.

Water flowing through the meters before the effective date will be charged at the current rate while water flowing through the meters on and after the effective date will be charged at the new rate.

The new rate is the rate proposed by City of Falmouth in its filing, but the Public Service Commission may order rates that differ from the proposed rate contained in this Customer Notice.

Intervention by Pendleton County Water District or another person with a substantial interest may be requested by submitting a timely written request for intervention by mail to the Public Service Commission, Post Office Box 615, Frankfort, Kentucky 40602. The request for intervention must establish the grounds for the request including the status and interest of the party.

If the Public Service Commission does not receive a written request prior to the effective date of the proposed rate, the Public Service Commission may take final action on the proposed rate.

Dear Mr. Monroe,

I hope this letter finds you safe and well. I write to notify you that the Northern Kentucky Water District Board of Commissioner's approved filing a rate adjustment request with the Kentucky Public Service Commission (PSC) last Thursday, June 30, 2022. The application is expected to be filed on or about July 8, 2022.

As part of the rate adjustment, the wholesale customer increase proposed would increase from the current rate of \$2.98 per CCF by \$0.23 to \$3.21 per CCF (7.7%) in year one and that in year two, the rate would increase by \$0.22 to \$3.43 per CCF (7.4%).

I will forward an electronic copy of the application once filed. Please note that our last rate adjustment request to the PSC was filed in September 2018. For our planning purposes, we do not anticipate that these proposed rates will be approved and implemented until January 1, 2023.
