SIERRA CLUB'S MOTION TO AMEND BRIEFING SCHEDULE

Comes now, Sierra Club, through its counsel, and respectfully asks the Commission, for good cause shown, to amend the briefing schedule set out in the Commission's November 21, 2025, Order in this docket. Sierra Club respectfully asks the Commission to extend all remaining deadlines by three days, which is equal to the number of days that Kentucky Power filed confidential responses to post-hearing requests for information after the Commission-established deadline.

In its November 21, 2025 Order, the Commission established the following deadlines:

- 12/5 Responses to post-hearing requests for information
- 12/9 Post-hearing briefs
- 12/15 Response briefs
- 12/16 Case submitted for a decision

Pursuant to the Commission's schedule, responses to post-hearing requests for information were to be filed on or before 12/5/25. On that date, Kentucky Power filed public

responses to requests for information and a motion for confidential treatment of certain

information.

On Saturday, December 6, 2025, counsel for Sierra Club emailed Kentucky Power

counsel at 8:43 a.m. requesting copies of all confidential responses to post-hearing requests for

information, which were not filed on December 5. On December 8, 2025, three days after the

Commission's established schedule – and just *one day* before post-hearing briefs are due –

Kentucky Power filed and served confidential responses, which include eight different

documents, including five Excel spreadsheets.

In order to avoid prejudice to Sierra Club and other intervening parties, Sierra Club

respectfully asks the Commission to extend all remaining dates set out in the November 21, 2025

Order by three days, equal to the number of days after the Commission's deadline that Kentucky

Power filed its confidential discovery responses. New case deadlines would be as follows:

12/12 Post-hearing briefs

12/18 Response briefs

12/19 Case submitted for a decision

Sierra Club contacted counsel for each party to this docket on the morning of December

8, 2025. Counsel for the Attorney General's Office neither supports nor opposes the Motion. As

of the time of this filing, which is being made as early in the day as possible given the existing

briefing schedule, none of the other parties had been able to provide their client's position on the

motion.
