**Kentucky Power Company's Motion For The Preparation
Of A Stenographic Transcription**

Pursuant to 807 KAR 5:001, Section 9(9)(a)(1)-(2), Kentucky Power Company respectfully asks the Commission to issue an order providing for a stenographic transcript of the hearing in this proceeding beginning November 18, 2025, to be prepared by a Commission-authorized court reporter. The Company understands that under 807 KAR 5:001, Section 9(9)(a)(3), it will be responsible for the cost of the transcript and having the transcript filed in the record within a reasonable time after the completion of the hearing.

The transcription will aid the parties in the briefing of this matter and may aid the Commission in its deliberations. The Company requests that the stenographic transcription be made with the court reporter present in the hearing room and not from the digital recording.

If the Company's motion is granted, Kentucky Power will retain the services of Kentuckiana Reporters. Specifically, April Camur will provide the reporting services. A copy of Ms. Camur's qualifications is attached as **EXHIBIT A** to this motion.

WHEREFORE, Kentucky Power Company respectfully requests the Commission enter an Order:

1. Providing for the stenographic transcription of the hearing scheduled to begin November 18, 2025, in this matter; and
2. Such further relief to which Kentucky Power may be entitled.
