MOTION FOR EXTENSION

Comes now the city of Greensburg ("Greensburg"), by counsel, and respectfully moves the Kentucky Public Service Commission ("Commission") for a ten-day extension to respond to the Commission Staff's First Request for Information ("Staff's First Request") in the above-styled case. In support of this request, Greensburg states as follows:

- 1. On June 26, 2025, the Commission entered an Order establishing this proceeding to investigate the reasonableness of Greensburg's tariff filed on March 20, 2025. On July 25, 2025, Commission Staff issued Staff's First Request with a due date of August 8, 2025.
- 2. Greensburg has not been able to gather the information requested in Commission Staff's First Request. The Mayor of Greensburg is the person responsible for gathering the information requested. Prior to the Commission Staff's First Request being issued, the Mayor had personal commitments already scheduled during the past two-week period. Although he still believed he would be able to gather the necessary information to meet the August 8, 2025, deadline, he has been unable to do so.
- 3. Greensburg is requesting the Commission to grant a ten-day extension to Monday, August 18, 2025 to allow the mayor time to compile the necessary information.

4. Greensburg understands the Commission does not look favorably upon motions for extensions however, Greensburg believes that a ten-day extension in this instance will not prejudice the Commission and there are no intervenors in the case.

WHEREFORE, on the basis of the foregoing, Greensburg respectfully requests that the Commission grant a ten-day extension to Monday, August 18, 2025 for Greensburg to respond to Staff's First Request.
