MOTION FOR EXTENSION OF TIME

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by and through counsel, and for its motion requesting that the Kentucky Public Service Commission ("Commission") grant a one-week extension for EKPC to file responses to Commission Staff's First Request for Information ("Staff's First Request") respectfully states as follows:

INTRODUCTION

EKPC filed its notice of intent to file this case on July 1, 2025. Commission Staff issued Staff's First Request on July 11, 2025, which stated the responses are due either twenty-one days after Staff's First Request were issued or fourteen days after EKPC's application was filed. EKPC filed its application on August 1, 2025, which made the responses to Staff's First Request due on August 15, 2025.

REQUEST FOR EXTENSION

EKPC has been diligently working on the responses to Staff's First Request; however, due to key personnel being out of the office and the amount of information that is needed to respond thoroughly to Staff's First Request, EKPC has been unable to complete its responses to Staff's First Request. EKPC requests a one-week extension to August 22, 2025 to respond to Staff's First

Request. The one-week extension will allow EKPC to complete the compiling of the information requested and also give EKPC the time needed to thoroughly review the responses to insure that EKPC is providing complete and comprehensive responses to Staff's First Request. The one-week extension will allow EKPC's key personnel time to return to the office and complete their review of the responses prior to filing with the Commission.

EKPC understands that the Commission does not look favorably on motions for extensions, but EKPC believes that a one-week extension is necessary and will not prejudice the Commission or any other party to this proceeding.

WHEREFORE, on the basis of the foregoing, EKPC respectfully requests that the Commission grant a one-week extension to Friday, August 22, 2025 for EKPC to respond to Staff's First Request.
