MOTION FOR DEVIATION

Comes now East Kentucky Power Cooperative, Inc. ("EKPC"), by counsel, respectfully requests the Kentucky Public Service Commission ("Commission"), pursuant to 807 KAR 5:001, Section 22, and other applicable law to grant a deviation of certain portions of the notice requirement in 807 KAR 5:001, Section 9(2). EKPC is requesting a decision on this matter by **November 7, 2025,** because that is the day the because that is the date *Kentucky Living* must finalize the notice for printing. Respectfully, EKPC states as follows:

- 1. On August 1, 2025, EKPC filed an application requesting an adjustment of rates. On October 8, 2025, the Commission entered an order setting a Formal Hearing in this matter on December 8, 2025.
- 2. 807 KAR 5:001, Section 9(2) requires a utility to provide notice of a hearing either by publication in a newspaper or by mailing notice to customers. If the notice of the hearing is

provided by newspaper publication, the notice must be published no less than seven (7) days and no more than twenty-one days (21).²

- 3. EKPC has the opportunity to publish notice of the December 8, 2025 Hearing in the December issue of *Kentucky Living* magazine. This will be mailed to members on, or about, November 26, 2025. A copy of the notice that will be provided to *Kentucky Living* is attached as Appendix A to this motion.
- 4. 807 KAR 5:001, Section 9(2)(a)(1) requires that a utility bear the cost of publication of the notice of a hearing. While rate case expense recovery is at the discretion of the Commission, it is typically for utilities to be allowed to recover the cost of publication of notice. In this case, EKPC has the opportunity to publish notice in *Kentucky Living* and due to the space needed for the hearing notice there will be no cost for the publication. EKPC expects significant cost savings for publication in *Kentucky Living* as opposed to the multiple newspapers that serve EKPC' service area.
- 6. EKPC will supplement the record at the time of publication with a copy of the notice and publisher's affidavit.

WHEREFORE, EKPC respectfully requests the Commission grant a deviation of 807 KAR 5:001, Section 9(2) pursuant to 807 KAR 5:001, Section 22 and permit EKPC to publish notice of the December 8, 2025 Formal Hearing by publication in *Kentucky Living*.
