**NOTICE OF WITHDRAWAL FROM SETTLEMENT**

---

Comes now East Kentucky Power Cooperative, Inc. (“EKPC”), by counsel, respectfully notifies the Kentucky Public Service Commission (“Commission”) it is withdrawing from the November 24, 2025 Joint Stipulation and Settlement Agreement pursuant to Paragraph Nine of the Agreement. Given the intense capital expansion EKPC is undertaking, EKPC cannot agree to the minimum three-year rate case stay-out in Paragraph 7(g) of the Settlement Agreement without approval of the Symmetrical Earnings Mechanism (“SEM”).<sup>1</sup>

WHEREFORE, EKPC respectfully informs the Commission it must withdraw from the November 24, 2025 Joint Stipulation and Settlement Agreement.
